Additionally volunteer acknowledges and agrees to follow all steps and social distancing as recommended or directed by governmental orders and directives, as well as those set forth in the attached Reminders which the volunteer acknowledges having read and agreed to.

Volunteer understands that the scope of the Volunteer's relationship with the Nonprofit is limited to a volunteer position and that no compensation is expected in return for services provided by the Volunteer; that the Nonprofit will not provide any benefits traditionally associated with employment to the Volunteer; and that the Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of their volunteer service to this Nonprofit.

I acknowledge that this Release discharges the Nonprofit from any and all liability or claim that I may have against the Nonprofit with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to the Nonprofit or occurring while I am providing volunteer services.
- 2. <u>Insurance:</u> I understand that the Nonprofit does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of the Nonprofit beyond what may be offered freely by the Nonprofit in the event of such injury or medical expenses incurred by me.
- 3. <u>Medical Treatment:</u> I hereby Release and forever discharge the Nonprofit from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the Nonprofit.
- 4. <u>Photographic Release:</u> I grant and convey to the Nonprofit all rights, title, and interests in any and all photographs, images, video, or audio recording of me or my likeness or voice

VOLUNTEER ROLES

- 1. Line monitors (reminding folks to social distance)-at least two in the middle of the line area and one at the end of the line (depending on how long the line gets)
- 2. Market Area counter (one person doing traffic counts every 15 minutes to ensure we are successfully monitoring a safe number of customers within the market area)
- 3. Entry/Exit Volunteers- to help control the number of customers in and out of the market area. These Volunteers will need to coordinate with one another by raising hands to show the number of people that have left or can enter into the market
- 4. Volunteers (2-3)- helping to chalk the area showing where to stand, how to enter vendor booths, happy messages on the sidewalk
- 5. Volunteers (2)- setting up cones and roping off the perimeter of the market with orange tape
- 6. Market perimeter monitors (2)- one volunteer on Cypress St. and one along Palm Ave.
